#### Internet User Agreement

- Access to the Internet is a privilege, not a right. This privilege is revocable by the Lab's administrator for violations of these rules.
- The use of the Internet is for research, homework and Club sponsored programs only.
- Within reason, freedom of speech and access to information will be honored; however, the administrator or instructor may review files and/or communications to insure compliance with the rules and regulations. Because of this users should not expect their use of the lab's computers to be private.
- While using the Internet at the Boys & Girls Clubs of Marin and Southern Sonoma Counties, the following are not permitted:

  - Downloading any music, software, games or any other possible file(s) without proper permissions from the Lab administrator
  - Violating copyright laws

  - Intentionally wasting limited resources
  - Social networking outside ynet website
  - Violent games i.e. fighting, weapons, blood

2. I understand that BGCMSCC maintains a NO REFUND POLICY.

4. I understand that in the event of extreme or recurring discipline problems, my child may not have use of the Club and/or participation in its programs for a prescribed period of time.
5. I, the parent, am registering my child in program(s) and am responsible for payment.
